**Current Business** discussion and overview:

Park pavilion: Completed, Bathroom project closed. Kitchen project, Denise is looking for equipment to finish.

Park walking path: Completed, project closed. Payment to Jessie is to be made in the amount of \$1000

Memorial scattering Garden: Nothing to update., the township is moving forward on this project

**Remus Survey:** Dee presented to the board that the survey monkey will cost \$99 a month. She would like to keep it up for two months for information to be collected. Nila made a motion that we move forward with the survey at that cost Amy seconded it, all in favor, motion carried.

**Remus DDA Boundaries.** Dee was able to obtain the original information from Linda Howard. The boundaries were discussed and at this time we see no need to change the current boundary lines established by the DDA **Grand Openings:** Amy will be contacting both the Vet and the Groomer to set up times and days to do ribbon cuttings.
